### Supplementary provisions to Regulations for recruitment for candidates to the interdisciplinary doctoral studies Och!DOK POWER project

“The development and application of the bioengineering and IT systems in the prevention, diagnostics and therapies of the civilization diseases – (enhance professional and personal skills/ development of vocational competence/comprehensive development of the professional qualifications) for the junior scientific staff”

#### I. General rules:

On the basis of the Regulation of the Minister of Science and Higher Education of 25 March 2020 amending the Regulation on the temporary limitation of the functioning of certain entities of the higher education and science system in relation to the prevention and combating of COVID-19, the supplementary provisions to the Regulations for the recruitment of doctoral students for POWER Och!DOK programme are established.

- 1) The recruitments of candidates for the POWER Och! DOK project is conducted through a competition conducted remotely using the available means of electronic communication.
- 2) The number vacancies available in supplementary recruitment for new participants of the Och!DOK project, determined in accordance with the number of participants declared in the project application, will be determined by the Project Leader - IBIB PAN based on current data concerning number of participants reported by members of the Consortium.
- 3) The recruitment process is conducted by the Recruitment Committee. The composition was determined in the Recruitment Regulations paragraph I point item 3.
- 4) Due to this special recruitment conditions with the candidate qualified to participation in the project a term contract will be signed. The contract will be concluded for the period from 1.05.2020 to 31.10.2020

#### II. Conditions of eligibility for the project

Candidates eligible to participate in the POWER Och!DOK project are the ones, who were accepted as the PhD students by one of the Institutes of the Consortium.

The information about competition will be sent electronically to the coordinators of the Doctoral Schools in the Partner Institutes and placed on the website of the Och!DOK project. In the information the date of documentation sending and approximate date competition will be included.

##### 1. Required documents

The candidates for the POWER Och!DOK projects shall provide the following documents, before the application deadline, to the IBIB PAN doctoral office [dzialprojektow@ibib.waw.pl](mailto:dzialprojektow@ibib.waw.pl):

- a. Candidate's application to participate in the POWER Och!DOK project, including the contact e-mail address (all recruitment information will be sent to the contact e-mail address) and telephone number available between 9:00 am to 2:00 pm.

- b. Draft of the planned scientific research (max. 1800 letters)
  - c. Declaration of the admittance to the Doctoral School
  - d. Supervisor Student's recommendation
- II. Recruitment Procedure
- 1. The Commission sets the date of interviews with candidates for the POWER Och!DOK project.
  - 2. The interview may be conducted in the form of a teleconference carried out by means of ICT tools, to which the candidate will receive an invitation to his email address.
  - 3. The candidate will be notified by e-mail about the result of the competition within 3 business days from the date of the interview.
  - 4. The remaining stages of the competition remain unchanged.
